The 1st Secretariat Meeting of our beloved Association has been started under the chairmanship of Sri Debasish Kumar Khatua, the President of the Association. He has conveyed his heartfelt gratitude to the Hon'ble Fisheries Minister, Shri Akhil Giri for his huge support & blessing for successful celebration of 33rd Biennial Convention of our beloved Association at Jahaj Bari, New Digha, Purba Medinipur dated 22-23 October, 2021. He has also conveyed his hearty thanks to all the proud Members of the Association for their huge participation to make the Convention a grand success. He has then congratulated to all Members of newly formed Secretariat Committee.

All Secretariat Members have taken active participation in the agenda-wise discussion of today's meeting and accordingly the following decisions have been made in the meeting:-

1. Approval of Secretariat Committee by PRSKF

The house has been informed that the Secretariat Committee of our beloved Association has been approved by Shri Dibyendu Roy, Convener, PRSKF. The Convener has already submitted the approved Committee

list to Hon'ble Fisheries Minister, Shri Akhil Giri and also to the Additional Chief Secretary, Fisheries Dept & the Director of Fisheries, West Bengal for their support and blessing to safeguard the right and interest of the Members of the Association as well as 35 lakh Fishermen families in the State confirming in the letter that the State Fishery Officers' Association, West Bengal is the one & only recognized Officers Association under PRSKF in Fisheries Department.

2. Reviewing Membership Status

As per the Bye-Laws of the Association, Officers including Fishery Extension Officer upto the Additional Director of Fisheries (Tech) are eligible for Membership of the Association. As the Members are the biggest asset for one Association, the decision has been made unanimously in the house that all possible efforts will have to be channelized to include all the eligible, honest, dedicated Officers of the Fisheries Department in the SFOAWB under the Paschimbanga Rajya Sarkari Karmachari Federation who are faithful to the ideology of Smt. Mamata Banerjee, Hon'ble Chief Minister of the present Maa-Mati-Manush Govt.

3. Transfer & Posting, Promotion, Recruitment

For effective and necessary steps for desirable transfer & posting, promotion and all other service related matters for the post of ADF/CEO-FFDA and onward, the following Sub-Committee has been formed:-

- 1. Dr. Anindya Sundar Ghosh Vice President
- 2. Dr. Kishor Dhara Vice President
- 3. Dr. Chinmoy Chakraborty Joint Secretary
- 4. Shri Dilip Kumar Mondal Joint Secretary

They will review & recommend all service related issues of the said Officers maintaining liaison with the President, Working President, General Secretary & Office Secretary and will take necessary steps to achieve the target. If necessary, the said Sub-Committee may include one or two Officers in the Team with the approval of the Secretariat Committee in the next Meeting.

For issues related to the Officers under WBJFS Gr-II & WBJFS Gr-I, the President, Working President, General Secretary and Office Secretary will do the needful.

This has been informed to the house that the Association has submitted rectified Gradation list of WBJFS Gr-I to the Department for its final notification. Association is also maintaining good liaison with the authority of the Department for promotion to all vacant posts of DFOs and onward.

It has been decided in the meeting that a Team of the Association will meet the DFWB soon to look the pending transfer proposal of the Members under the WBJFS Gr-II cadre. The decision has also been made to meet the authority of the Department to look the pending transfer proposals of WBJFS Gr-I and WBFS cadre.

It has also been decided in the meeting unanimously that following transfer policy will be followed by the Association during transfer & posting of the Members of different cadre:-

- A. WBJFS Gr-II:- 1st 4-6 years, anywhere/furthest place. Atleast 10 years working experience at Block, the Members will be eligible for District level posting.
- B. WBJFS Gr-I:- Those have less than 3 years service period, Association will try to post him nearest as per the availability of the option.
- C. WBFS: 3-4 years rotational basis. Last 3 years, nearest as per available option.

However, in each cadre, there will be exception in extreme cases with the approval of Secretariat/CEC.

Decision has been made to submit the appeal to the Hon'ble Fisheries Minister, Shri Akhil Giri for his kind consideration and steps for filling up of all vacant posts other than 100 approved posts of Officers under the WBJFS Gr-II cadre from the panel of ongoing PSC Recruitment process.

4. Re-Structuring of Fisheries Directorate

The decision has been made in the meeting that a Team will meet the Additional Chief Secretary & the Additional Secretary of the Department with a request to complete the restructuring of the Fisheries Directorate as early as possible as per the recommendation of Special Task Force on Fisheries constituted by Hon'ble Chief Minister, Smt. Mamata Banerjee.

5. Publication of Matsya Kahon

Shri Chamak Mazumdar, Joint Secretary (Magazine) has been requested to take immediate steps to publish the 1st Edition of Matsya Kahon within this December, 2021. He has been ensured that all necessary supports will be given by the Association as per his requirement.

6. Developmental Proposals

Decision has been made to meet the authority of the Department to pursue the submitted development proposals by our Association.

7. Change of Bank Operators

The decision has been taken in the meeting that the Bank Operators for both the Savings Bank Account i.e. State Bank of India, Colootola Branch (AC No 10109048163) and the Indian Bank (Previously Allahabad Bank), Kolkata Chittaranjan Avenue Branch (AC No 20106737682) are needed to be changed and Debasish Kumar Khatua, the President, Debasish Haldar, the General Secretary and Kingshuk Mukhopadhyay, the Treasurer will be the Bank A/C Operators for said two Savings Bank Account of the Association.

9. Miscellaneous

- a) To solve the service related problems of the Officers deputed under FFDAs and Health scheme related problem of the Officers posted under GTA, a Team of the Association will meet the appropriate authority of the Government soon.
- b) Golden Jubilee Year of the Association will be celebrated in 2022.
- c) Farmers Meet/Awareness Camp will be made regularly.
- d) For conducting any programme, prior approval/discussion in Secretariat/CEC is made mandatory.

e) For successful completion of day to day activities of the Association, a Secretariat Member may take an advance of maximum Rs 15000/- (Fifteen thousand) only from the Treasurer. To get the next advance, he must have to submit the adjustment of the previous advance with supporting Bills/Vouchers etc. The Treasurer may take advance of Rs 50000/- (Fifty thousand) only.

Any expenditure icw the activity of the Association by any Member with prior intimation to the President/Working President/General Secretary/Treasurer/Office Secretary is reimbursable with the supporting Bills/Vouchers etc.

- D The gift icw 33rd Biennial Convention will be sent through currier soon to the District Head Quarter District Secretaries of Kolkata, Howrah, Hooghly, North & South 24 Pgs. Purba & Paschim Medinipur. Purba & Paschim Medinipur, Nadia & Murshidabad will collect it from the specified place, date & time in Kolkata.
- g) Decision has been made in the house to invite Dr. Sk. Abul Kashem, the Ex-General Secretary & the Ex-Working President of our beloved Association in each Secretariat & CEC meeting of the Association till his retirement.
